Official welcome back to Paula Green!

- The CrossForm Initiatives is a leadership team development series that worked with HT and six other churches across the country to evaluate program and overall church health and develop initiatives to strengthen the core of leaders and teams to increase resources, impact, and flexibility in changing times. CrossForm has been useful for us to vision new ministry for impacting our community, and though the learning process has come to completion, there will be ongoing initiatives and future teams to dream next growth opportunities for our community and our ways of being in mission to the world.
 - Sign Proposal (Tina) narrowed down and refined designs for flags and yard signs to present to the congregation. Lynnette and Tina will send out the final draft and then seek pricing and loop team back in with costs and timeline for getting signs.
 - o Reconciling Ministries –(Carol) Reconciling Ministry Network website (rmnetwork.org) has been informative. They strongly recommend 1:1 conversation (signs may help us start to do this) to discuss the process and the goal. This is a long process that requires buy-in (75-80%) and indepth conversation to even get to the point of deciding if this is the right step for Holy Trinity. Next step will be seeking advice from other congregations who have done this. The goal of becoming a reconciling church is to publicly be in ministry with and for all people. (LGBTQIA+, race/ethnicity, ability/disability...all means all.) Nine to twelve month process (could be more.) Core Team supported Carol doing further exploration.
 - Support GED/ESL Learners (Deanna) Patty Hubbard and Deanna have been helping tutor an adult couple seeking their GEDs. Covid has set them back a few weeks but they are regrouping this week.
 - Updated Church Directory (Tanya) All the pictures that are expected to be turned in are
 probably in. She will be matching faces with contact info to get the document done before the
 next meeting in March. There will be an electronic option and a printed option will also be
 available. (Ten copies will be available at church, or available for purchase as requested.)
 - Partnership with local school (Chad) Tabled for now

Finances

- O January Financial Update (Jeff) In January everything looks kind of green just because there is not a lot of information. There were a few larger donations (including people giving for the entire year), so we need a few more "normal" months to get a better picture. Still looking at what are the reports we need and the questions that need to be asked in order to get a total picture of the financial health of our church. - o HT will be reinstating the Finance Team, seeking delegates from SPR and Trustees, who would meet quarterly. The smaller task force made up by Jeff Erlandson (Finance Chair,) Deanna

Hawkins (Core Team Chair,) Kelly Loose (church Bookkeeper,) and Pastor Chad will meet as needed to monitor financials through the year and work through strategic initiatives.

- Children Youth Families Update (Lynnette) We had six middle and high school youth attend The Event at the end of January (an evening experience of connection, message and fun.) The Anti-Racism training for Youth and Parents was informative with approximately 20 in attendance in person and online. The first week of March we are offering to take students to Just One, a suicide prevention event with a speaker at The Well in Rosemount. There will be a youth option for the Lenten Study Love Is The Way (but no one has signed up yet...) A 6 day mission trip to Rapid City and the Black Hills of SD is planned, dates TBD soon but either sometime the last few weeks of June or the last full week of July. Last day of Sunday school will be on May 22 and the Bread Oven team is planning a Pizza Party and there will be live music by The Jumpin' Jehoshaphats.
- Covid Precautions: have decided to move back to "recommended" masking versus "required." While
 hospitalizations and new cases are decreasing, many members are immunocompromised or
 apprehensive about variants. We will continue to support anyone who wishes to wear a mask, but
 will not require people to do so.
